We currently are seeking individuals with a background in accounting or finance; with connection to or lived experience of the rural environment; or with a legal background, or individuals with a set of knowledge or skills that can contribute to the advancement of the organization.

Eligibility

All directors elected by the members must:

- Be members of the Corporation, or become members within ten (10) days of their nomination;
- Not have been employed by the Corporation for at least twenty-four (24) months;
- Be able to communicate fluently in French and in English;
- Adhere to the Corporation's mission, objectives, policies and by-laws;
- Consent to a criminal record check;

- Have accepted in writing their appointment to the board of directors;
- Have not been declared incapable of managing their property by a competent court;
- Not to be considered bankrupt;
- Be at least eighteen (18) years old.

Key responsibilities

The board of directors is responsible, on behalf of the members, for ensuring the sound management, compliance with applicable laws and regulations, fulfillment of the mission and continuity of the Corporation. The board of directors may adopt such policies, directives or other rules and procedures consistent with these by-laws as it deems appropriate.

The following is a non-exhaustive list of the board's responsibilities:

- Provide strategic leadership
- Oversee financial health
- Support good governance
- Participate in executive oversight
- Ensure accountability and transparency
- Prepare for and participate in board meetings, including the Annual General Meeting
- Safeguard compliance
- Engage in board development and contribute to a positive, effective board culture
- Act as ambassador for the organization
- Uphold fiduciary duties by acting in the best interest of the organization
